2019-20 Catalog Changes

This document outlines significant changes that were made to the catalog from last year's catalog.

- 1. Nationwide locations are now referred to as Columbia College Global locations, with the name change now reflected throughout the catalog.
- 2. The <u>About Columbia College</u> section was updated to reflect campus location changes, student and alumni number changes, and resource number changes.
- 3. In <u>Academic Honors</u>, the words "with advisor approval" was added to the rule that allows honor's students to take unlimited credit hours without paying an overload fee.
- 4. In Accrediting Agencies, the number of Columbia College locations was updated.
- 5. Admissions Policies were updated to include to following information:
 - Prospective students applying within two weeks of a session start date may not allow enough time to complete requirements and secure financial aid.
 - <u>International Student Admissions</u>: Housing availability clarified; International students admitted to Elgin, Salt Lake and Denver registration restrictions clarified; English proficiency requirements updated.
 - Non-degree –seeking students cannot change to degree-seeking status in the middle of a semester.
 - High School Dual Enrollment definition clarified
 - High School Dual Credit: Definition, application process and qualifications outlined.
- 6. The <u>Admissions Policies Pertaining to Special Programs</u> page was revamped with the admissions procedures and specific processes for Teacher Certification Programs, the Associate of Science in Nursing Program, RN-to-BSN Online Program, Bachelor of Science in Nursing Program and Certificate Programs.
- 7. In <u>Advising and Registration</u>, the Registration Policies sections were updated to include statements about possible financial implications of dropping or withdrawing from a course.
- 8. In Applying for Financial Aid, eConsent was added as a step to the process.
- 9. The <u>Articulation Agreements</u> page was updated to include all current partners.
- 10. On the <u>CC Global Resources</u> page, information for the <u>Enrollment Service Center</u> was added. Information about MOBIUS membership was also added to the Stafford Library section.
- 11. On the <u>Grading and Academic Standing</u> page, the <u>Assessment</u> section was updated with new Writing Seminar and First Year Experience course requirement. The Main Campus Day <u>Grade Appeal</u> process was also updated.
- 12. In the <u>International Programs</u> section, the number of hours each semester was updated and CPT eligibility requirements were updated.
- 13. On the <u>Main Campus Day Aid Information</u> page, we've updated the <u>Scholarships, Grants and Awards</u> section.
- 14. In the <u>Main Campus Day Resources</u> page, a section was added for the <u>Enrollment Services</u> <u>Center</u> and <u>Center for Student Leadership</u>.
- 15. On the <u>Main Campus Day Student Affairs</u> page, the <u>Grossnickle Career Services</u> section was updated with contact info and information on their new Handshake software. The <u>Housing Requirement</u> section was also updated with the new policy. <u>Student Health Services</u> was updated and a section was added for <u>Student Medical Insurance Policy</u>.

- 16. In the <u>Main Campus Evening Aid Information</u> section, multiple scholarships/awards were removed and new ones were added.
- 17. On the <u>Online and CC Global Student Affairs</u> page, the <u>Grossnickle Career Services</u> section was updated with contact info and information on their new Handshake software.
- 18. On the <u>Resources</u> page, the number of alumni was updated, Enrollment Services Center information was added, and library numbers were updated. <u>Parking Permits</u> information and <u>Bookstore/Textbook policy</u> was updated.
- 19. On the <u>Return of Title IV Funds</u> page, we updated the determining earned aid section to include what happens when a student withdrawals multiple times.
- 20. On the <u>Student Conduct</u> page, policy on the Alcohol and Controlled and/or Illicit substances was updated. The Behavioral Misconduct policy was also updated along with the Disciplinary Procedures. The General Student Grievance Policy was also updated.
